NOW, THEREFORE, BE IT RESOLVED, that the Town Board authorizes Supervisor Crossen to execute the NYSDOT Municipal Snow & Ice Program Agreement Adjustment/Calculation Worksheet for Index Lump Sum Agreements for the 2022/23 Snow & Ice Season with an increase of \$50,022.09.
