Town of Alabama Media Policy

The purpose of this media policy is to ensure accurate, positive, message consistency, and a clear order for all to follow.

Therefore, it is the policy of the Town of Alabama that, except for the Town Attorney and Chairpersons of the Planning and Zoning Boards at their respective public meetings, all Elected Officials, Employees, and Appointees are to refer all media inquiries to the Town Supervisor.

The Town Supervisor may then respond directly, authorize another Town Official to respond, seek counsel from the Town Attorney prior to response, or refer the inquiry to the Town Attorney for response.

National Grid is working on plans to re-route power lines.

Part of Crosby Road will be closed to allow work on the STAMP site. Will notify the Town when the road will need to be closed.

Resolution Granting Consent to the Construction of a Water System and Sewage-Works System

WHEREAS, the Town Board of the Town of Alabama (the "Town Board") Genesee County, New York, previously consented to the formation of a sewer-works corporation, STAMP Sewer Works, Inc. ("STAMP SWC"), under the provisions of Article 10 of the Transportation Corporation Law ("TCL"); and

WHEREAS, the Town Board has received an assessment of the feasibility and adequacy of the plans and specifications of the sewage-works system.

We, the members of Town Board do hereby adopt, approve and ratify the following resolutions:

RESOLVED, that the Town Board does hereby consent to the construction of the sewage-works system by STAMP SWC, pursuant to the plans and specifications previously provided to the Town Board and previously approved by the Genesee County Health Department; and be it further

RESOLVED, that the Town Board hereby waives: (i) the posting of a performance bond or other similar bond or guaranty for the cost of construction of the sewage-works system or other guaranty for the payment of labor and material furnished in the course of such construction; (ii) the provision of a guaranty that STAMP SWC will maintain and operate the sewage-works system for a period of at least five years; and be it further

RESOLVED, as required by the TCL, that the Town Board accepts the stock of STAMP SWC in escrow, with title passing to the Town Board, in the event of abandonment or discontinuance of the maintenance and operation of the sewage-works system.

<u>COVID-19</u>

COVID Relief monies will be available, will have four years to spend it. Could be anywhere from \$171-\$300,000. Supv. Crossen to update Board when more information is available.
